TANK CLEANER aids in the reduction of spray tank residue. Since the amount of residue varies, individual conditions will directly affect use rates of TANK CLEANER.

USE RATES

1 quart of TANK CLEANER treats up to 100 gallons of spray solution. Circulate cleaning solution throughout entire system. Use high pressure spray to clean and rinse interior of spray tank. Purge tank systems, spray lines and nozzles. Drain out and completely rinse tank again using clean water. Always use enough TANK CLEANER to completely remove all residues.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. disposal. Protect from freezing. Store above 32°F. Do not store near strong oxidizing materials, acids, or chlorine. Do not reuse empty container. Dispose of in a safe manner in accordance with local, state, and federal regulations.
